Sub: Short Term Open Access Charges.

Haryana Electricity Regulatory Commission vide its order dated 29.03.2013 on ARR for Transmission Tariff, SLDC charges & ARR OF UHBVNL & DHBVNL FOR THEIR DISTRIBUTION & RETAIL SUPPLY BUSINESS for the year 2013-14 has revised Short Term Open Access charges.

The revised charges for short term open access customers to be implemented and recovered as per Haryana Electricity Regulatory Commission order referred above are as under:

Short Term Open Access Charges

1. **Transmission Charges** 17 Ps / kWh (ARR order for FY 13-14) + 2 Ps/KWh (impact of HERC order dt. 02.11, 12) = 19 Ps/KWh.

2. **SLDC Charges** Rs. 2000/- per day or part of the day

3. Intrastate losses

2.5%

4 Wheeling charges including distribution losses: 70 Ps/KWh for using distribution system

Further necessary action in the matter may be taken accordingly. The transmission charges and operating charges U/S 25 of CERC (Open Access in Interstate Transmission) Regulation 2008 and subsequent amendment vide section 12 of CERC order be recovered from the future Short Term Open Access Customers on the revised rates as above.
