No. JERC- 14/2010 : In exercise of powers conferred under Section 181 of the Electricity Act, 2003 and all other powers enabling it in this behalf, and based on the revised tariff policy of 28 Jan 2016 a need has arisen to amend certain provisions of the JERC (Procurement of Renewable Energy) Regulations, 2010.

#### 1. Short title and commencement:

- (1) These regulations may be called the Joint Electricity Regulatory Commission for State of Goa & Union Territories (Procurement of Renewable Energy), Third Amendment Regulations, 2016
- (2) These regulations shall come into force from the date of their publication in the official Gazette.
